TERMS AND CONDITIONS

- i) The Annual contract of Pest Control treatment service will be operational for one year, extendable further for another one year on same terms and conditions, if agreed by both the Parties.
- ii) The Contractor shall provide service twice a year through experienced and qualified staff duly authorized by the contractor.
- iii) **Responsibility of the Contractor:**
 - a) The Contractor should strictly adhere to the statutory regulations VIZ Minimum wages Act, Shops and Establishments Act, PE Act, ESI Scheme and any other regulations covering labour contract where applicable.
 - b) The Contractor shall be totally responsible for the entire safety of labours, Supervisors and surrounding areas of the work sites where Contractor work and shall use safety items to ensure that the workers are working under utmost safety conditions. The Contractor will ensure immediate availability of proper and adequate First Aid Facilities to all Employees/ Workmen employed by it at work site.
- iv) **General Conditions:**
 - a) The site shall be kept neat and clean at all times throughout the duration of the work at no extra cost to the Commission and on completion of the work the site shall be in original condition and recover the cost so incurred from Contractors bills.

- b) The Contractor will carry out the work as per the discussion and instruction of the Commission from time to time. The Contractor shall maintain instruction book at site. The instruction/comments received from the Commission should be compiled General Disinfestations Treatment, the Commission shall inform the Agency and the entire job should be completed within 02 days (Saturday & Sunday) of the start of the work.
- c) This is the entire Agreement between the parties and no alteration or amendment is valid unless signed by a person duly authorized by the Contractor and the authorized signatory of the Commission.
- d) In case of any dispute the decision of Secretary of this Commission would be final and binding. Disputes occur out would be dealt in the court of jurisdiction only at Panaji.
- e) During the currency of this agreement, the Commission, if it so desires will be free to terminate the agreement by providing 30 days advance notice of termination. The Contractor, if he/she so desires will be free to terminate the agreement by providing 30 days advance notice of termination.
