## PART-I

**ORGANISATION****1. BACKGROUND.-**

Goa, Daman & Diu was incorporated as a Union Territory with Legislative Assembly in 1962. The establishment affairs i.e appointments of Gazetted Officers were being managed by the Union Public Service Commission, under Article 320 of the Constitution of India and this practice continued till Goa was declared as 25<sup>th</sup> State of India on 30<sup>th</sup> May, 1987.

As per Article 315 of the Constitution it was felt necessary either to have a separate Public Service Commission for the new state of Goa or to attach the function to one of the Public Service Commission of the nearby State. The popular Government decided to have a separate “Public Service Commission” of its own and accordingly on 30<sup>th</sup> May, 1988 i.e. on the eve of first anniversary of the Statehood, the State Government established Goa Public Service Commission (GPSC).

Under Part XIV, Chapter I and in Articles 308 to 314 of the Constitution of India, the matter related to services under the Union and the States such as recruitment and conditions of service or person serving, dismissal, removal or reduction in rank of persons employed have been provided.

Under Chapter II, subject to the provisions of the Article – 315, there shall be a Public Service Commission for the Union and a Public Service Commission for each state.

Article 316 deals with the appointment and term of office of the Chairman and Members of PSCs.

Article 317 provides the procedure for removal/suspension of Chairman or Members of PSCs.

Article 318 gives the power to make regulations as to the conditions of service of Members and staff of the Commission.

Article 319 prohibits the holding of offices under government by the Members of the Commission on ceasing to be such members.

Article 320 lays down the function of the PSCs. It also makes a reference to Clause 4 of Article 16 and Article 335 of Constitution of India.

Article 321 permits the exercise of additional functions by PSC's based on Act passed by Parliament/Legislature.

Article 322 lays down that expenses of the PSC's shall be "Charged" on the Consolidated Fund of India or of the State.

Article 323 deals with the submission of annual reports by the PSC's to the President/Governor and its being laid before the Parliament / Legislature. The Commission has so far brought out **Thirty Fifth** Annual Reports since its inception.

## **2. VISION & MISSION.-**

The Goa Public Service Commission pursuant to the provisions laid down in the Constitution of India endeavors to support the human resources capability of the Government through absolute transparency, fairness, use of advanced technology platforms and to endeavor provide best human resources in all Group "A" and "B" posts in Goa Government administration in most transparent manner.

### **New Initiative by the Commission**

- Working environment was made more professional through a well designed office space.
- Introduction of Computer Based Recruitment Test (CBRT).
- On the spot declaration of results of CBRT to increase the credibility of the system.
- Restructuring automation and procedural overhaul of the existing recruitment and promotion system for speedy completion of process of recruitment/promotion in more transparent manner.
- Complete stoppage of ad hoc promotions for all categories of posts to encourage the Departments to consider regular promotions.
- Regular update of Recruitment Rules which are more than Ten years old.
- Introduction of Grievance Redressal System for CBRT

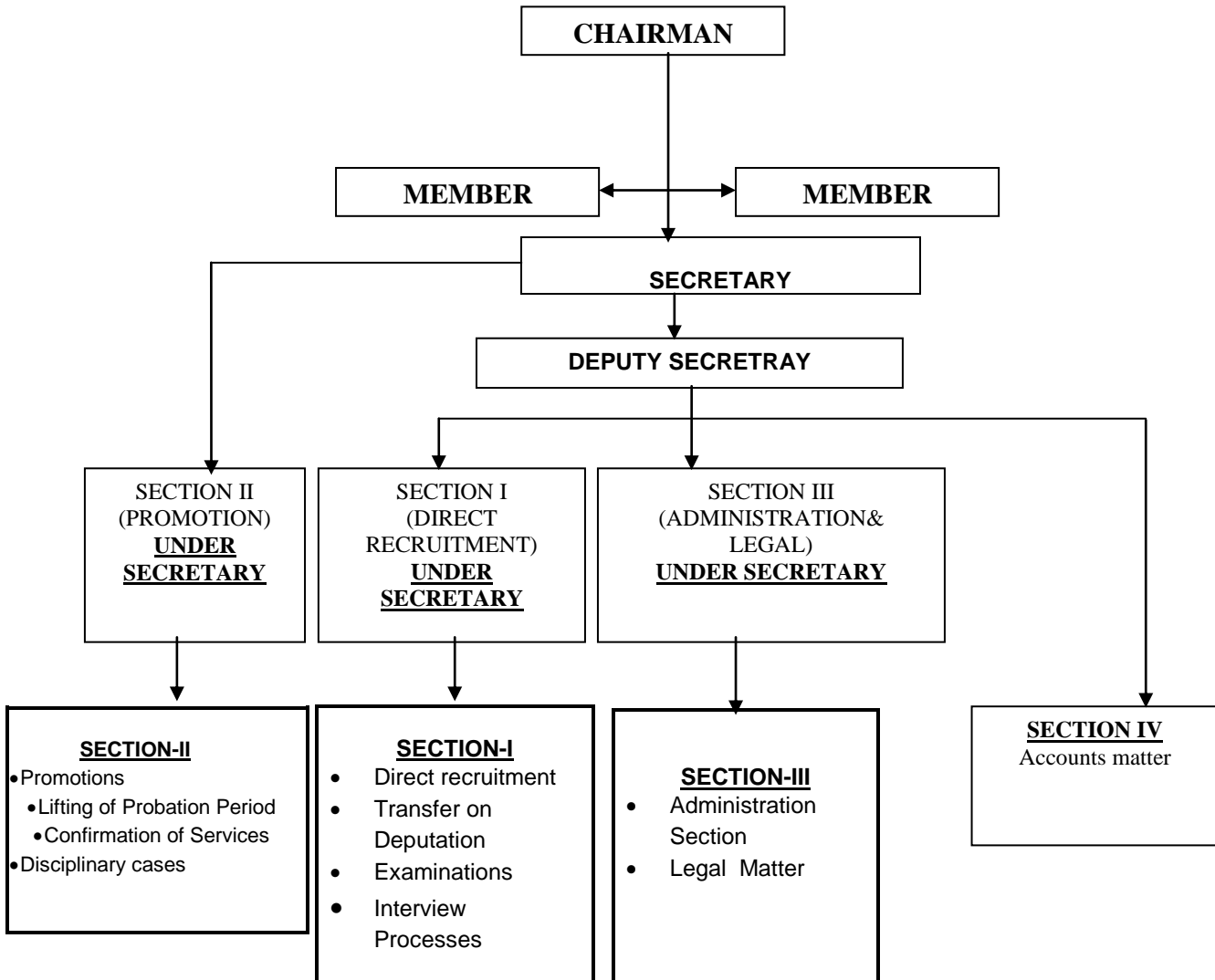

**5. STAFF STRENGTH.-**

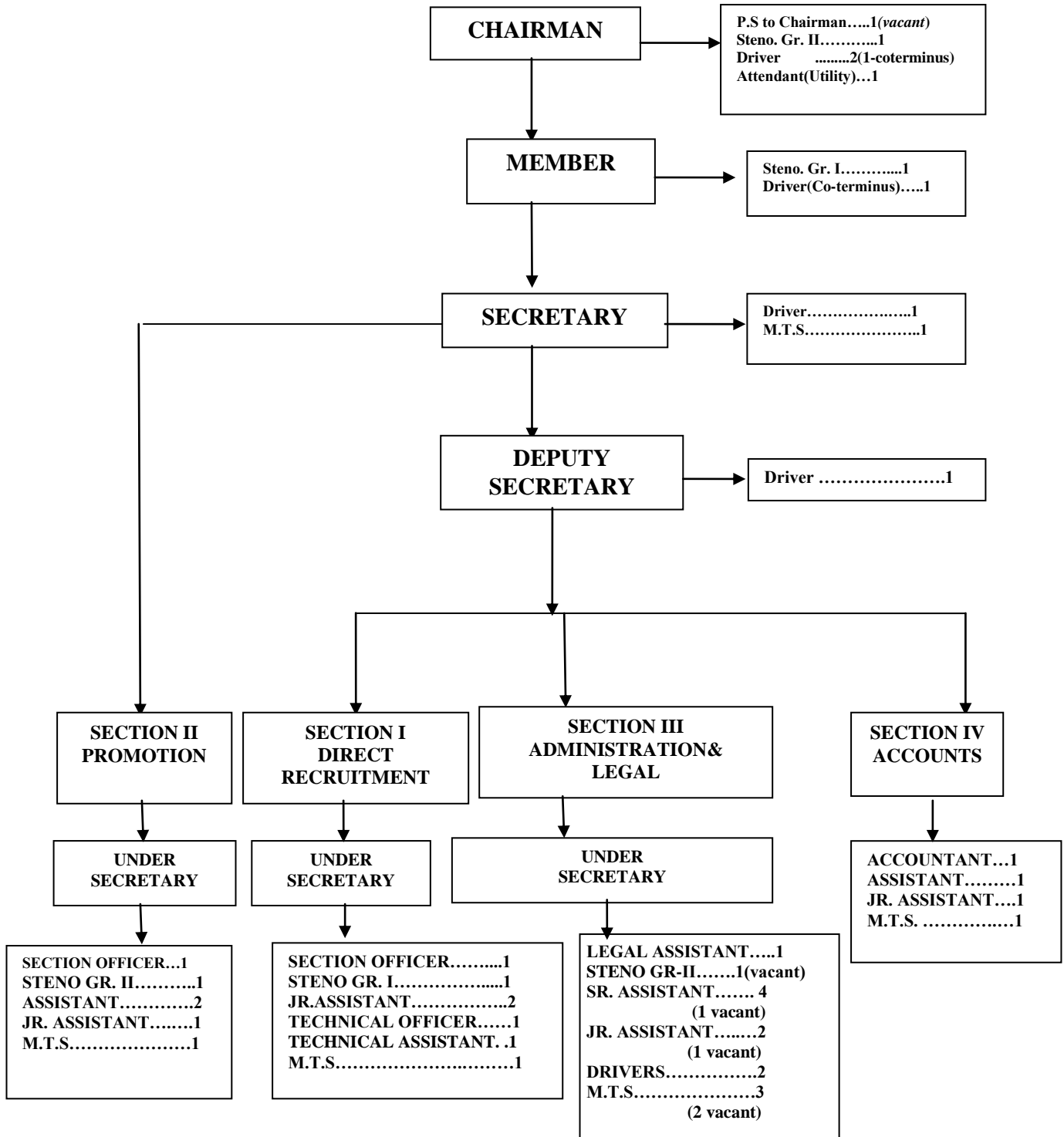
The total sanctioned staff strength of Group ‘A’ ‘B’ and ‘C’ is **42** against which **37** staff were in position during the year.

## 6. FUNCTIONS OF THE COMMISSION.-

In pursuance to the Article 320 of the Constitution of India the Commission is consulted in the matters of Direct Recruitments, Promotions, Framing of Recruitment Rules and Amendments thereto, satisfactory completion of probation period, confirmations, continuation of ad-hoc promotions/ appointments beyond one year, Disciplinary Proceedings, in respect of Group 'A' and 'B' posts. Certain categories of the posts have been exempted from the purview of the Commission by virtue of the Goa Public Service Commission (Exemption from Consultation) Regulation, 2020.

The Commission presents to the Hon'ble Governor of Goa its Annual Report for the period from 1<sup>st</sup> April 2023 to 31<sup>st</sup> March 2024 in accordance with the requirement set out under Article 323 (2) of the Constitution of India.

## 7. WARRANT OF PRECEDENCE.-

There has been no change in the Warrant of Precedence. The Chairman of the Commission is shown in Article 23 along with the Chief Secretary and Director General of Police and the Member of the Commission is shown in Article 25.

## 8. FINANCIAL MATTERS.-

The Commission is provided with funds under Budget Head **2051**-Public Service Commission, 102-State Public Service Commission, 01-State Public Service Commission (Charged), **2071**- Pension and Other Retirement Benefits, 01- Civil, 117-Government Contribution for Defined Contribution Scheme, 01- Defined Contribution Pension Scheme, 01- Salaries and **4059**-Capital Outlay on Public Works, 01-Office Building, 051-Construction, 01-Construction to GPSC - Building & Infrastructure. During the financial year i.e. **2023-2024**, an amount of **₹ 821.70 Lakhs** (Rupees Eight crores twenty one lakhs seventy thousand only) has been provided in the budget estimates. Though the Commission is not a revenue earning department, the Commission collected **₹ 73.92 Lakhs** (Rupees Seventy three lakhs ninety two thousand only) by way of application fees, examination fees and R.T.I. fees, etc. during the period under report. The total expenditure incurred for the year under report is **₹ 742.90 lakhs** (Rupees Seven crores forty two lakhs ninety thousand only).

**11. ADVERTISING THE POST UNDER DIRECT RECRUITMENT.-**

- 3) Tarun Bharat/Gomantak/Lokmat (alternatively)

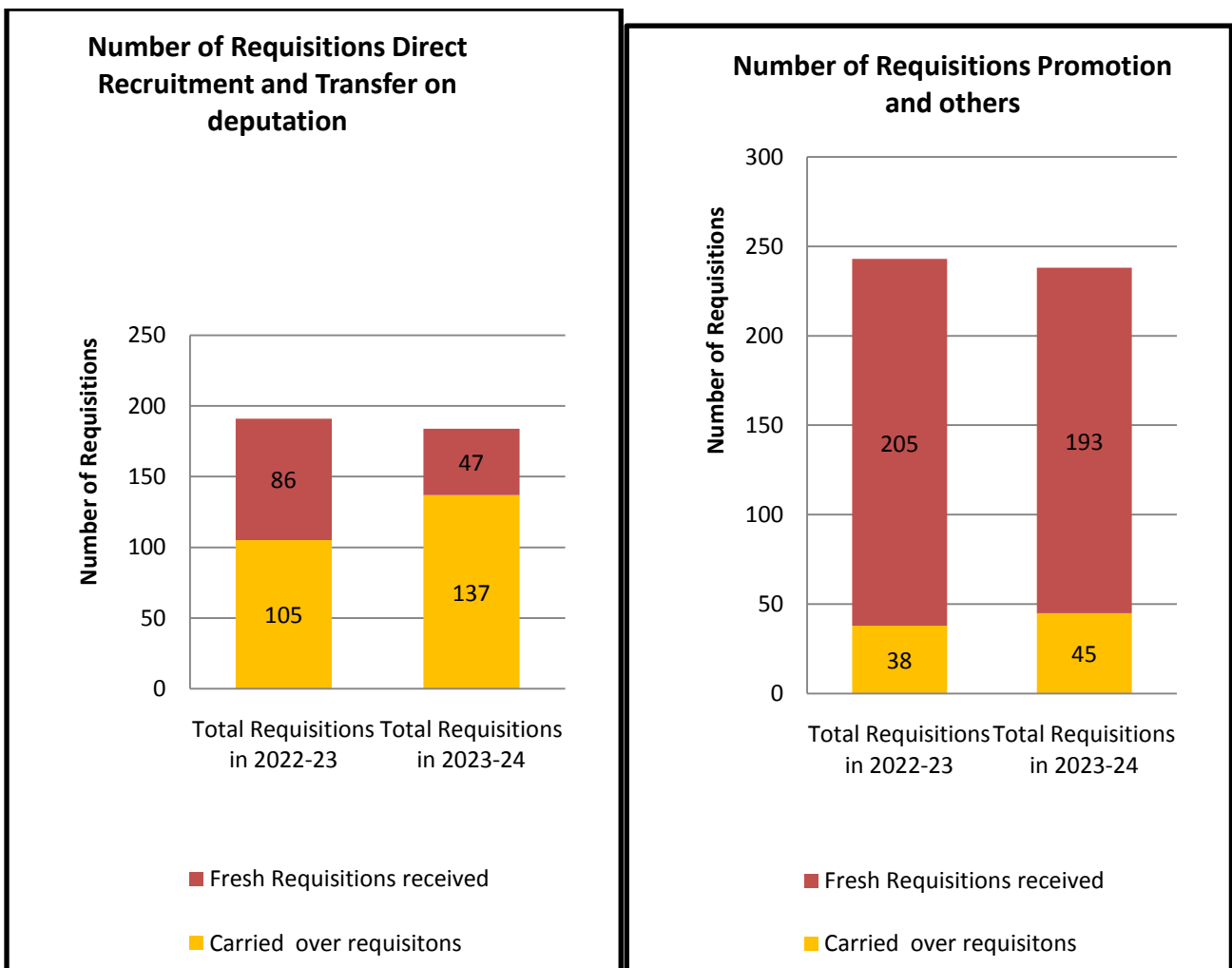
Further Commission decided in Commission's meeting dated 9/1/2023 to advertise the vacancies in 6 widely circulated newspapers in the State of Goa ie. two English , one Konkani and Three Marathi regularly.

- 2) Bhangarbhuy (regularly)
- 3) Tarun Bharat , Gomantak and Lokmat (regularly)

In order to facilitate the response from prospective candidates in rural areas, copies of the advertisements are sent to the Office of the Collectorate, Mamlatdar, B.D.O., Police Stations for displaying on their Notice Board. The advertisements are also uploaded on the Commission's website for wide publicity and are sent to Goa Doordarshan and All India Radio. Similarly, advertisements notifying the vacancies are also published in the "Goa Vacancy and Tender Bulletin" issued by the Government Printing Press. Applications for all advertised positions are received online through the Commission's website.

**12. REQUISITIONS RECEIVED BY THE COMMISSION.-**

During the period under report, the Commission received **40** requisitions for filling up the post by direct recruitment, **6** requisitions for filling up the post by transfer on deputation, **1** requisition for filling up the post by re-employment, **193** requisitions for filling up the post by promotion and other requisitions such as framing of Recruitment Rules, Amendment of Recruitment Rules, satisfactory completion of probation period, confirmation, disciplinary cases, etc. The details of which are shown in **Statement I**. 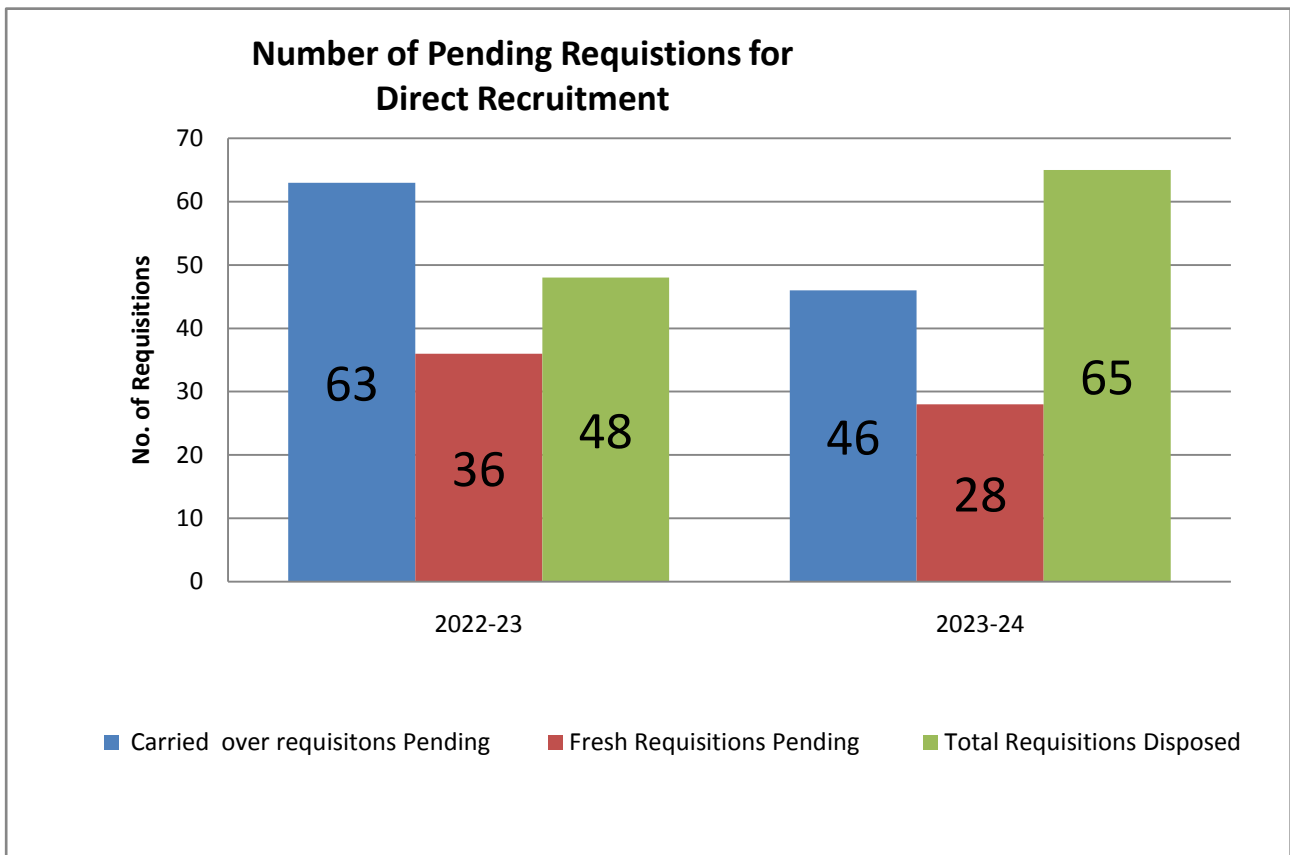


**13. DIRECT RECRUITMENTS.-**

**13.1 Requisitions.-**

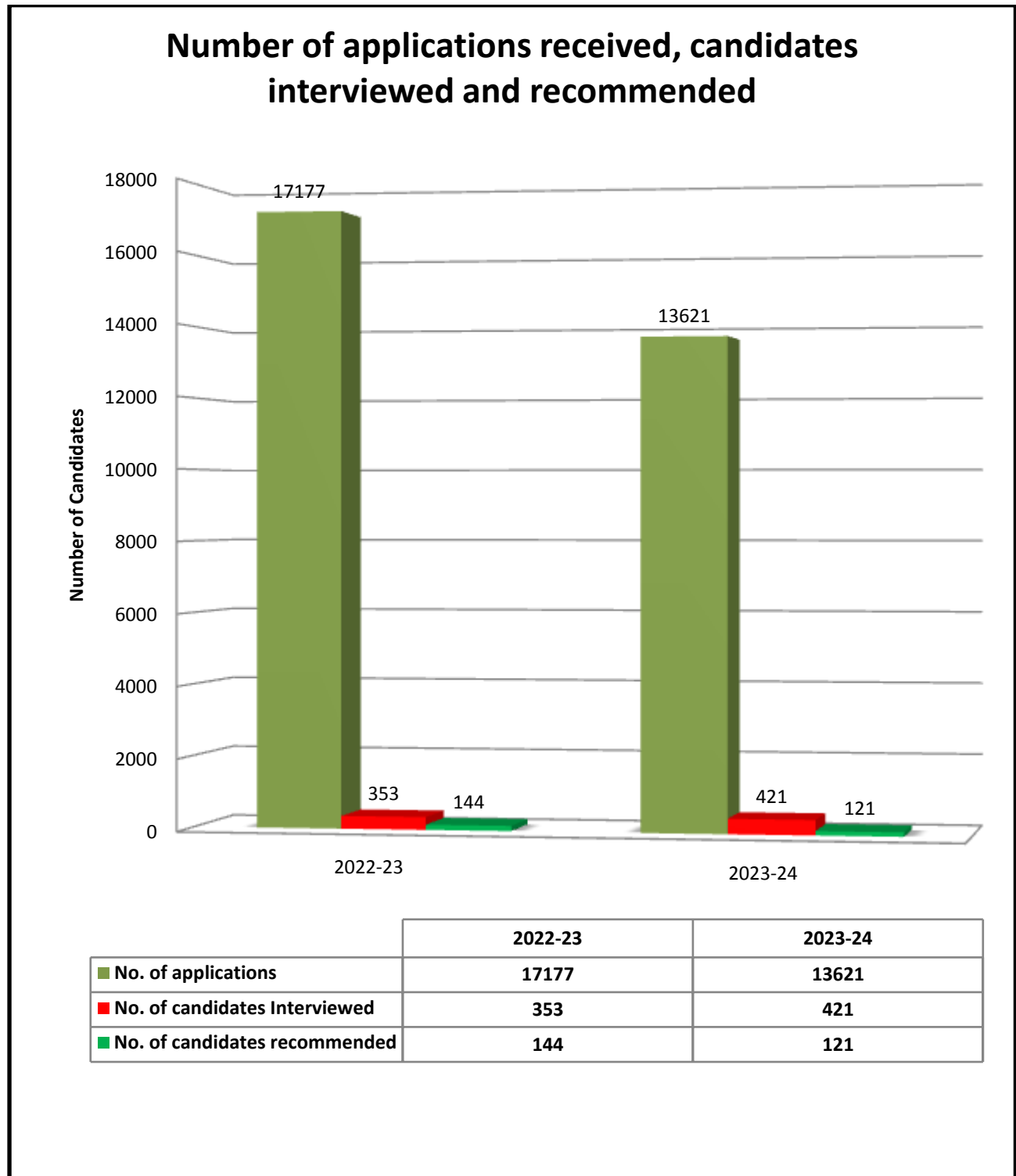
- a) **99** proposals were pending with the Commission as on 01.04.2023. **53** Requisitions out of **99** are disposed off .The details are shown department wise in **Statement II**.
- b) During the period under Report, the Commission received **40** new requisitions from various Government departments for various posts. **12** requisitions out of **40** are disposed off. The details are shown department wise in **Statement III** during the period under report.
- c) At the end of the Financial Year, **74** proposals are pending due to various reasons given in the remarks column of **Statement II and III**.
- d) **38** proposals were pending with the Commission as on 01.04.2023 for filling up the posts by Transfer on deputation/Short term contract out of which **3** are disposed off. **6** new proposals were received by the Commission for filling up the posts by Transfer on deputation/Short term contract. **2** requisitions out of **6** are disposed off. At the end of the Financial Year, **39** proposals are pending due to various reasons given in the remarks column of **Statement V** during the period under report.
- e) During the period under Report, the Commission received **1 new** requisition for filling up the post by re-employment. This single requisition is disposed off. The detail is shown in **Statement VI** during the period under report

**14. NON ACCEPTANCE OF THE COMMISSION'S RECOMMENDATION.-**

**The Commission renders necessary advice to the Government with regard to the matters entrusted under Article-320 of the Constitution of India.**

Article 323 enjoins upon the Commission to forward a Report of its activities to the Governor, who shall cause a copy thereof, together with a memorandum explaining, as respect the cases, if any, where the advice of the Commission was not accepted, the reasons for such non-acceptance to be laid before the Legislature of the State.

Commission had recommended 1 post of Principal in Government Polytechnic under Directorate of Technical Education. However, the Hon'ble High Court vide its judgement dated 27/09/2023 has set aside the given recommendation.

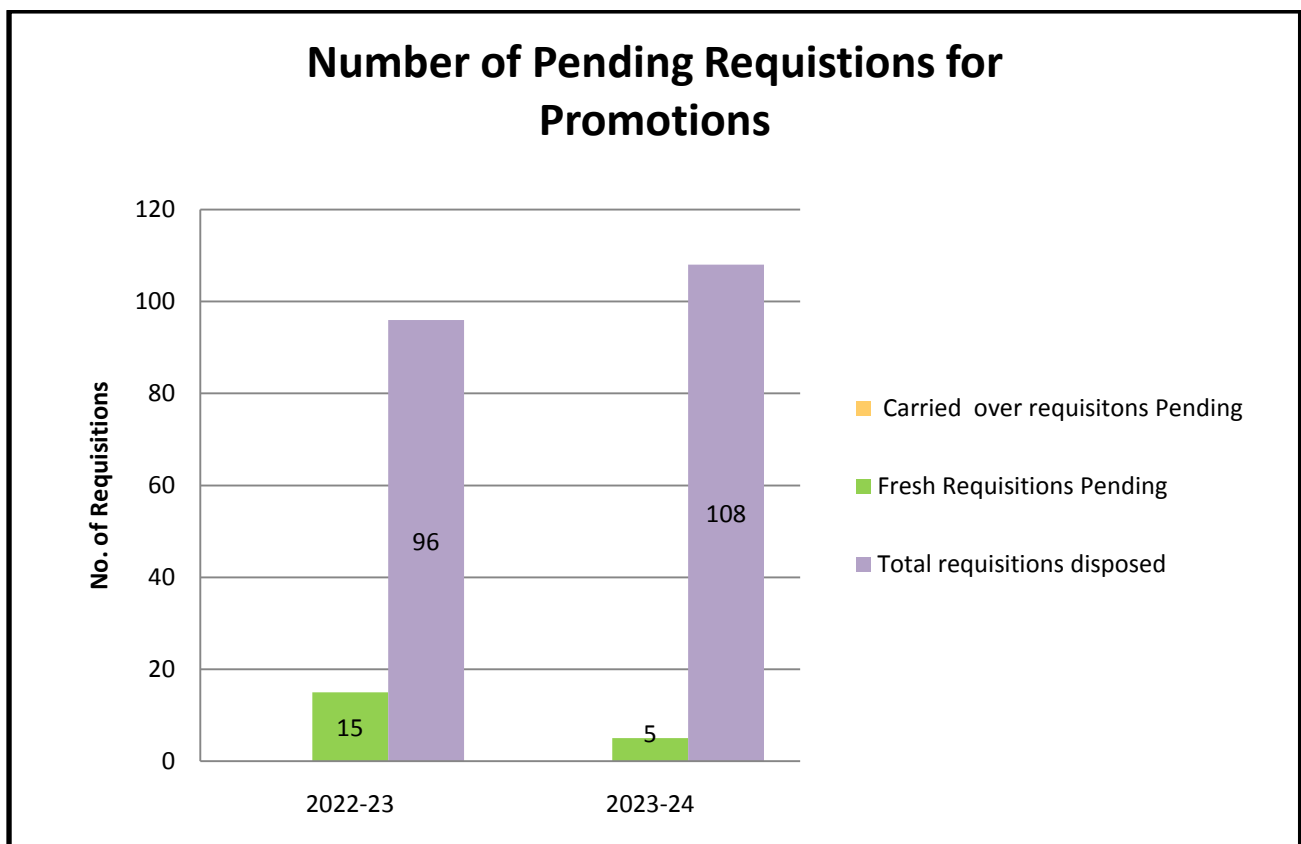

**16. PROMOTIONS.-**

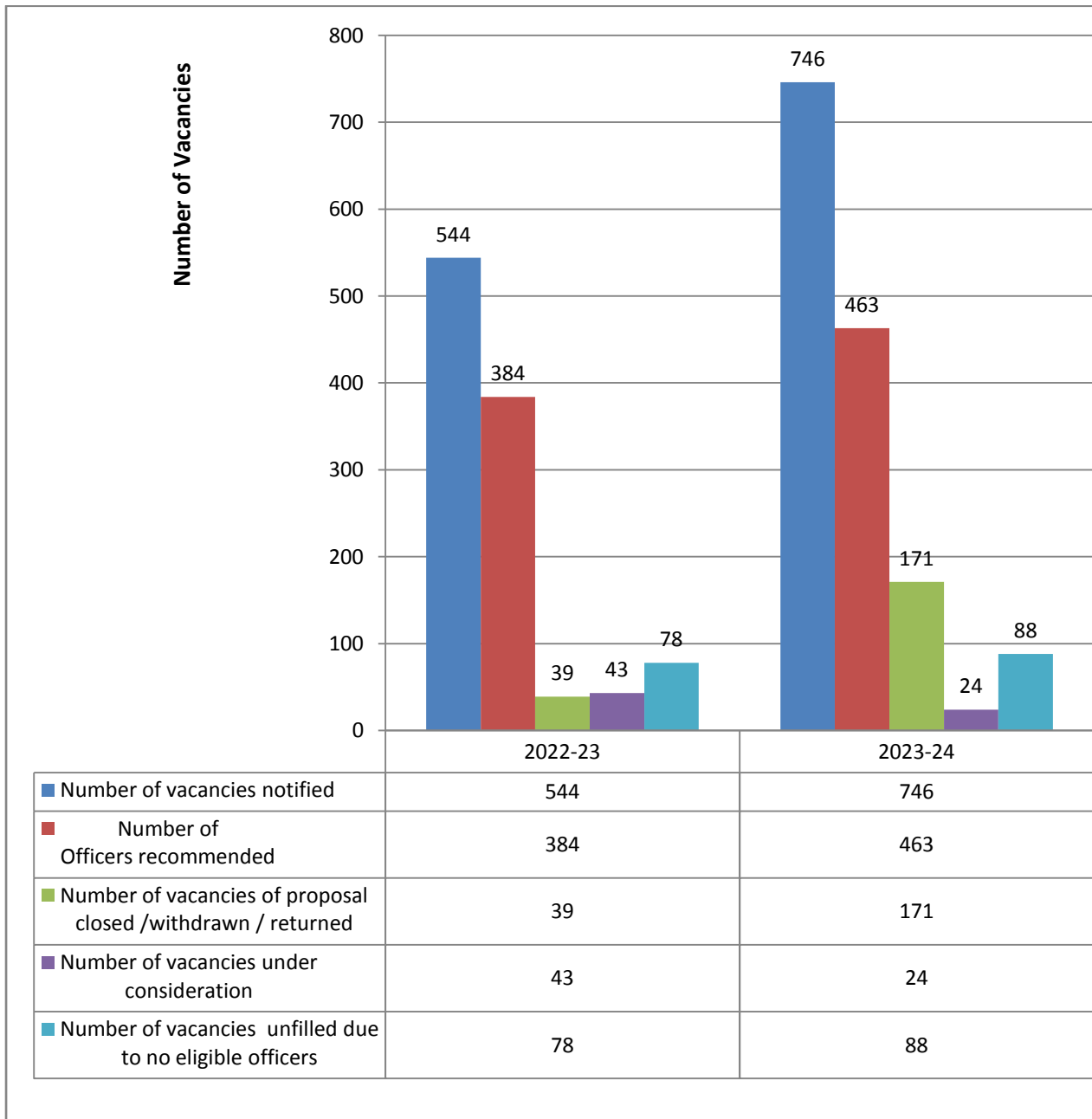
At the beginning of the year, 15 proposals covering 43 vacancies were pending. During the year under report 98 proposals were received for 703 existing vacancies to be filled in the various Departments. The Commission disposed of 108 proposals which include 15 pending proposals of the previous year. 171 vacancies which include 22 vacancies of the previous year were returned/ withdrawn.

The Commission recommended 463 officers for promotion which include 16 Officers of the previous year. 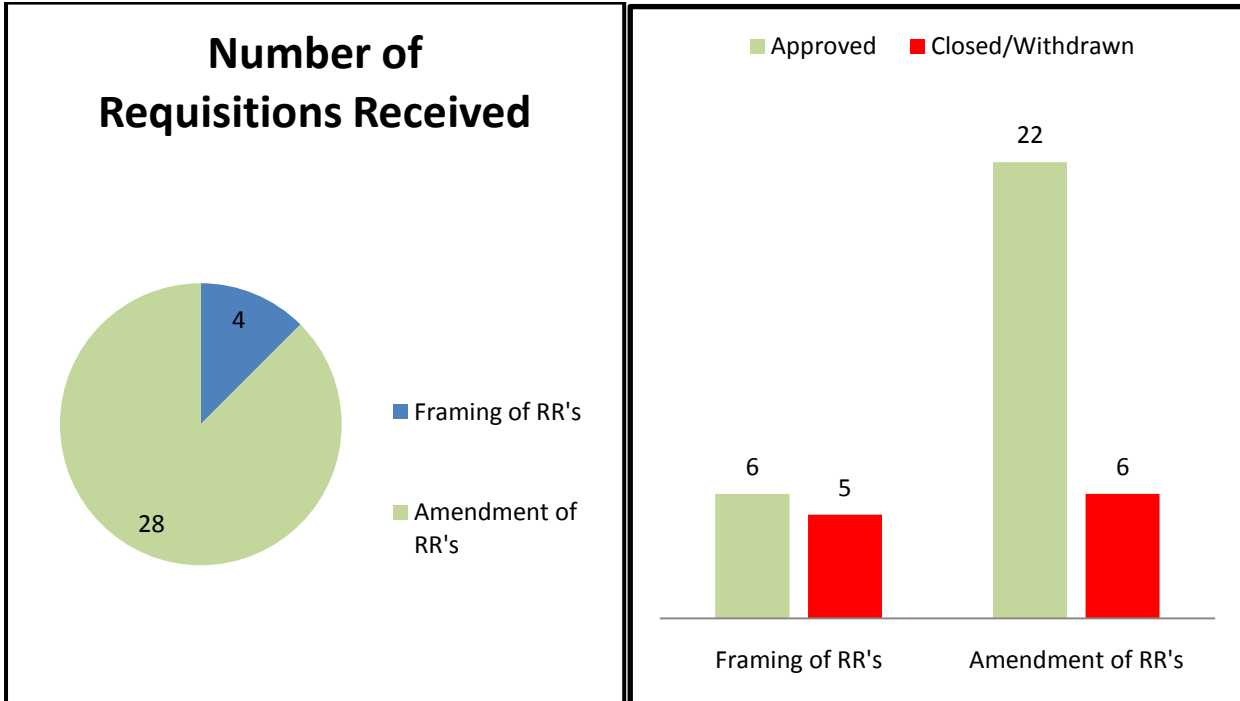
**16.1 Statistical Abstract of Number of vacancies notified, to be filled by promotion and Number of officers Recommended.-**

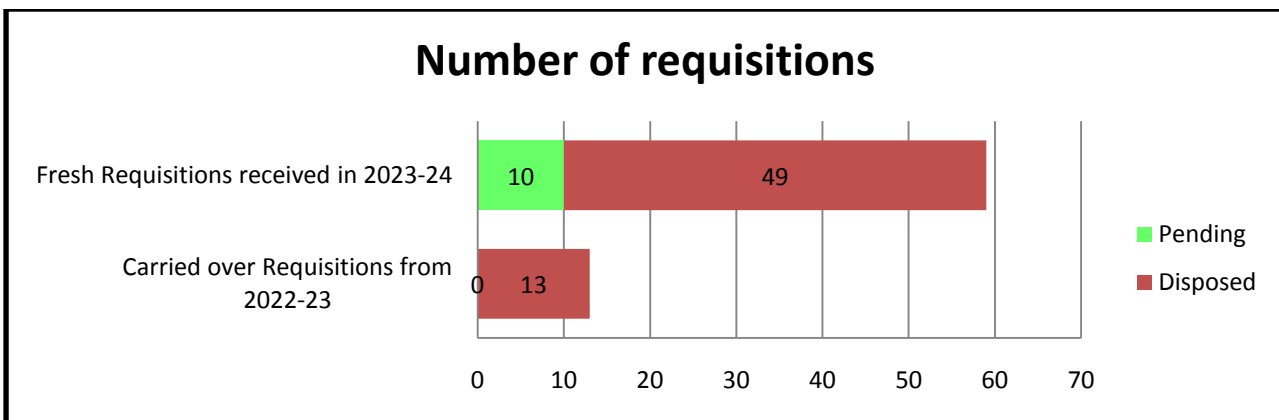
**17. RECRUITMENT RULES AND AMENDMENT THERETO.-**

**18. CONFIRMATION/PROBATION PERIOD.-**

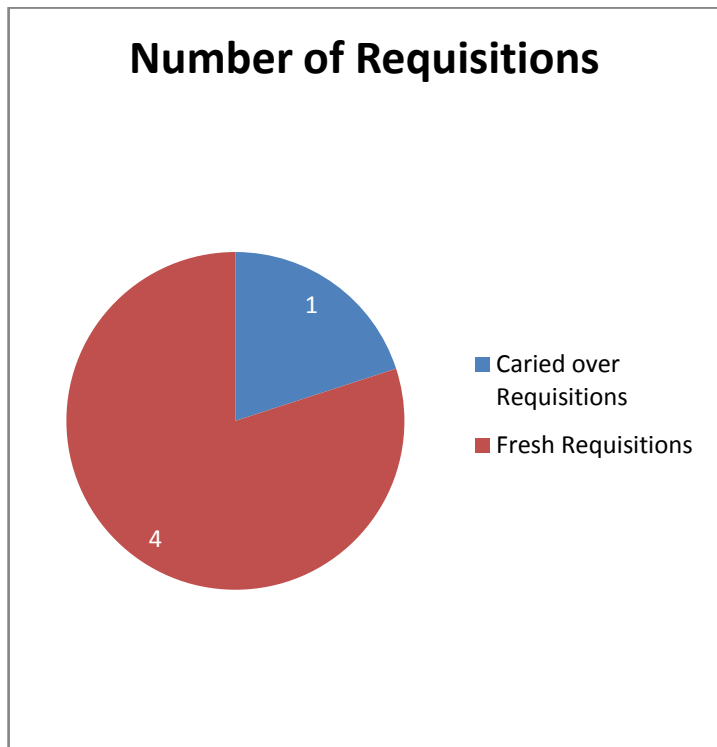

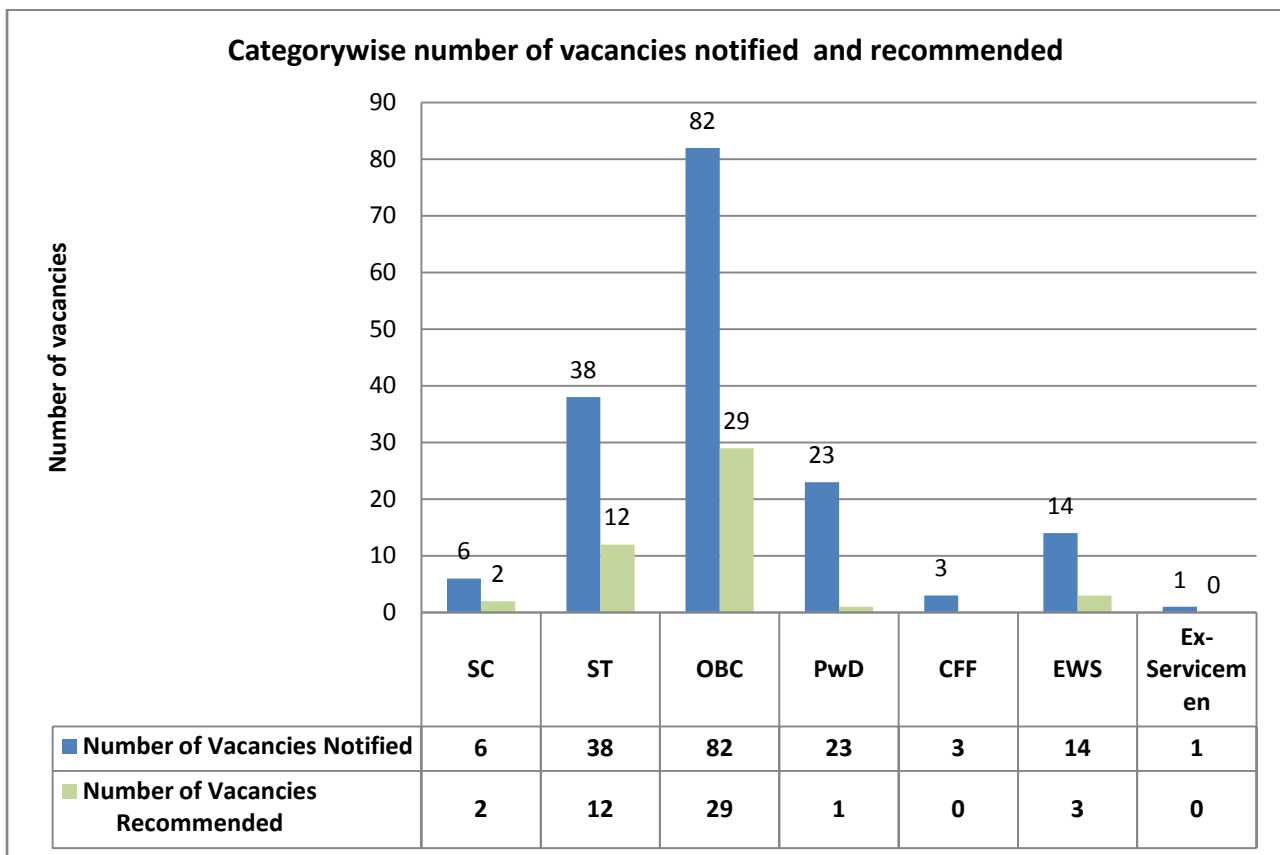
