PART-I

ORGANISATION

1. BACKGROUND

Goa, Daman & Diu was incorporated as a Union Territory with Legislative Assembly in 1962. The establishment affairs i.e. appointments of Gazetted Officers were being managed by the Union Public Service Commission, under Article 320 of the Constitution of India and this practice continued till Goa was declared as 25th State of India on 30th May, 1987.

As per Article 315 of the Constitution it was felt necessary either to have a separate Public Service Commission for the new state of Goa or to attach the function to one of the Public Service Commission of the nearby State. The popular Government decided to have a separate “Public Service Commission” of its own and accordingly on 30th May, 1988 i.e. on the eve of first anniversary of the Statehood, the State Government established Goa Public Service Commission (GPSC).

Under Part XIV, Chapter I and in Articles 308 to 314 of the Constitution of India, the matter related to services under the Union and the States such as recruitment and conditions of service or person serving, dismissal, removal or reduction in rank of persons employed have been provided.

Under Chapter II, subject to the provisions of the Article – 315, there shall be a Public Service Commission for the Union and a Public Service Commission for each state.

Article 316 deals with the appointment and term of office of the Chairman and Members of PSCs.

Article 317 provides the procedure for removal/suspension of Chairman or Members of PSCs.

Article 318 gives the power to make regulations as to the conditions of service of Members and staff of the Commission.

Article 319 prohibits the holding of offices under Government by the Members of the Commission on ceasing to be such members.

Article 320 lays down the function of the PSCs. It also makes a reference to Clause 4 of Article 16 and Article 335 of Constitution of India.

Article 321 permits the exercise of additional functions by PSC's based on Act passed by Parliament/Legislature.

Article 322 lays down that expenses of the PSC's shall be “Charged” on the Consolidated Fund of India or of the State.

Article 323 deals with the submission of annual reports by the PSC's to the President/Governor and its being laid before the Parliament / Legislature. The Commission has so far brought out Thirty-Six Annual Reports since its inception.

2.VISION & MISSION

The Goa Public Service Commission pursuant to the provisions laid down in the Constitution of India endeavors to support the human resources capability of the Government through absolute transparency, fairness, use of advanced technology platforms and to endeavor to provide best human resources in all Group “A” and “B” posts in Goa Government administration in most transparent manner.

Proposed Initiatives for the Next Financial Year

1. Modernizing Office Infrastructure

- Replacement of outdated computers and printers to enhance staff productivity and efficiency.

2. Strengthening Security Measures

- Installation of CCTV cameras across office premises to ensure safety and secure working environments.

3. Digitization of Recruitment Processes

- Streamline various recruitment workflows by transitioning to a fully digitized system, improving transparency and efficiency.

4. Implementation of e-Office Software

- Adoption of e-Office software to facilitate seamless daily file processing and improve record management.

5. Paperless Interview Management System

- Introduction of portable tablet computers for interview experts, enabling a fully paperless interview process and contributing to environmental sustainability.

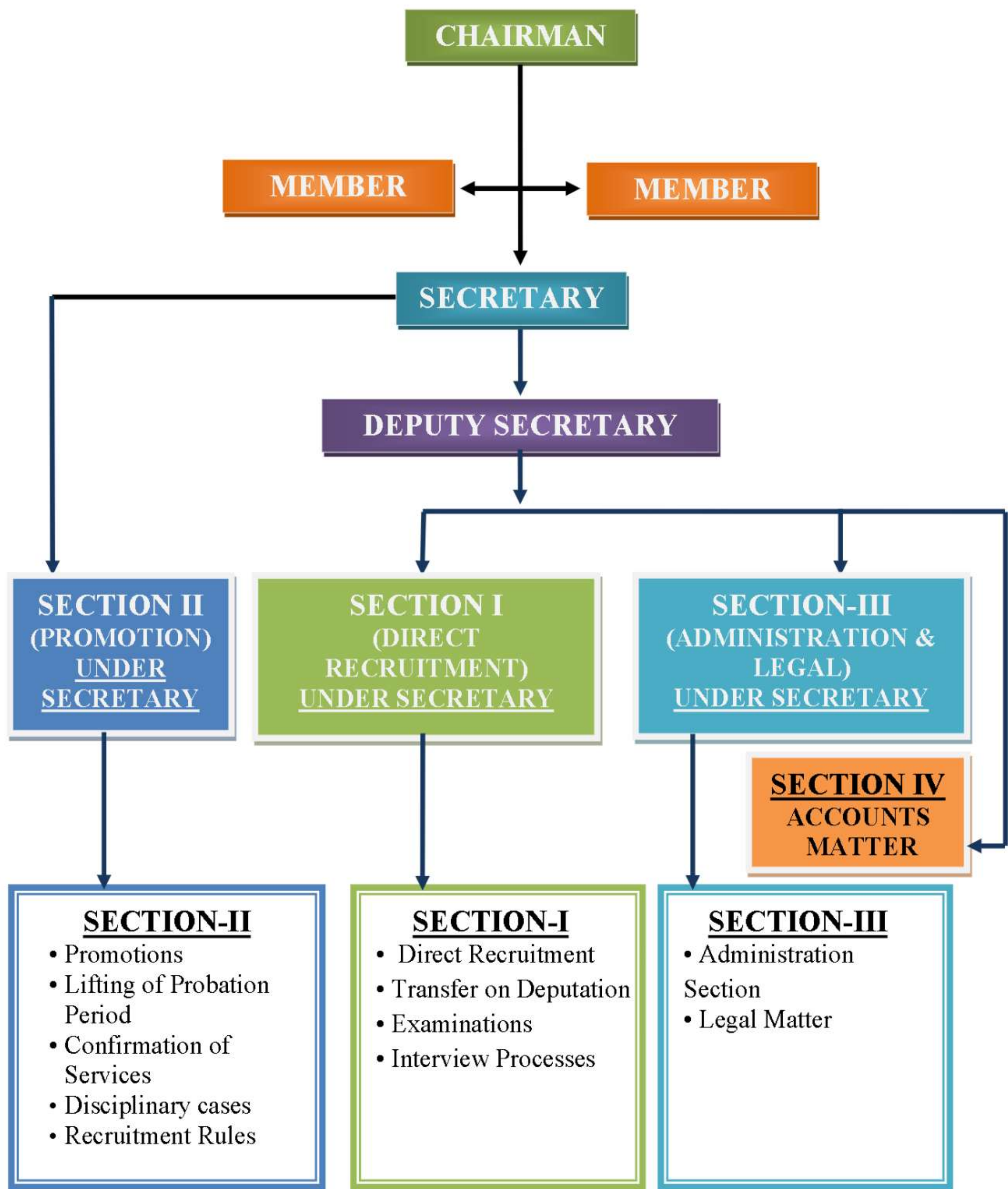

6.STAFF STRENGTH

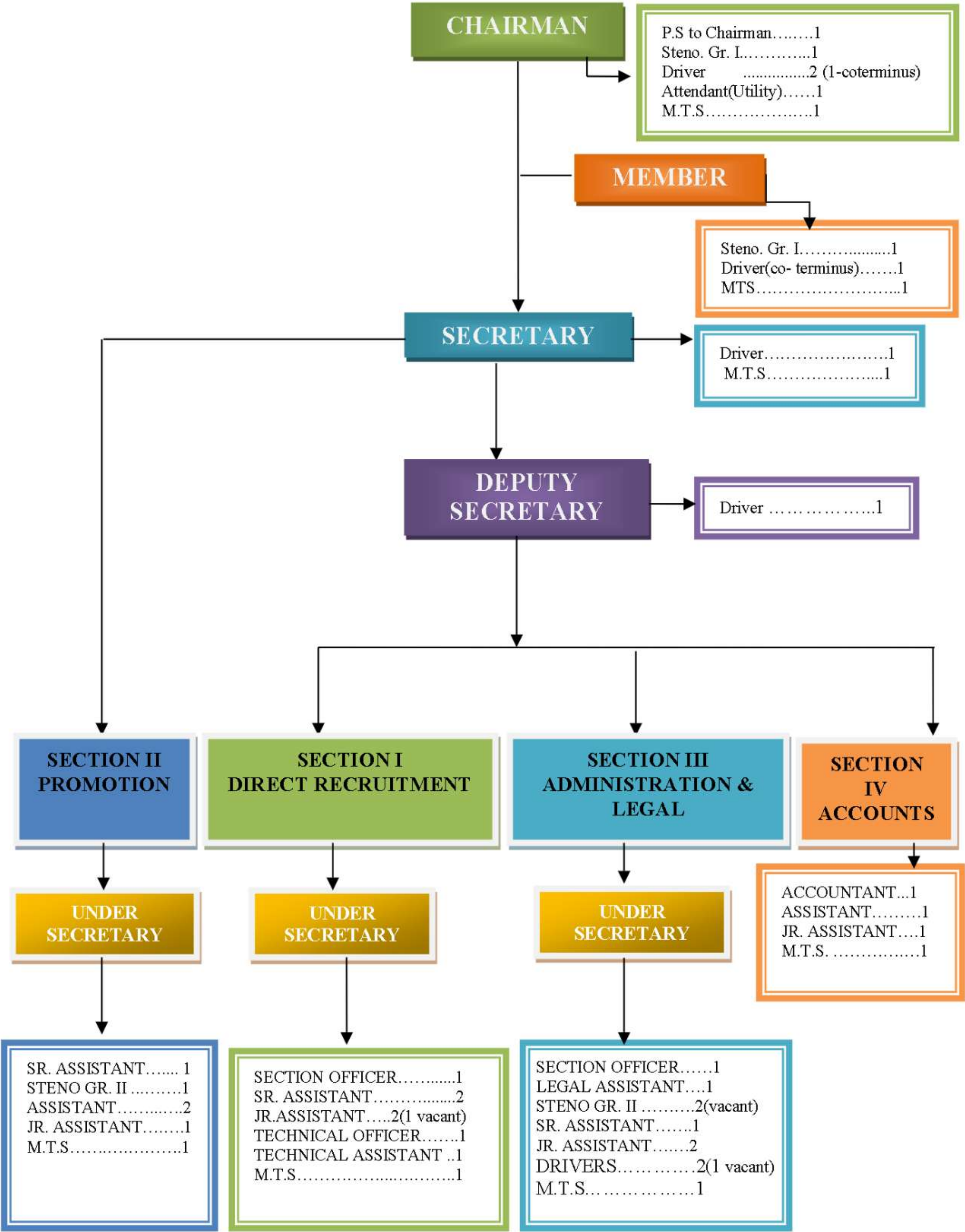
The total sanctioned staff strength of Group ‘A’ ‘B’ and ‘C’ is 42 against which 37 staff were in position during the year.

6.FUNCTIONS OF THE COMMISSION

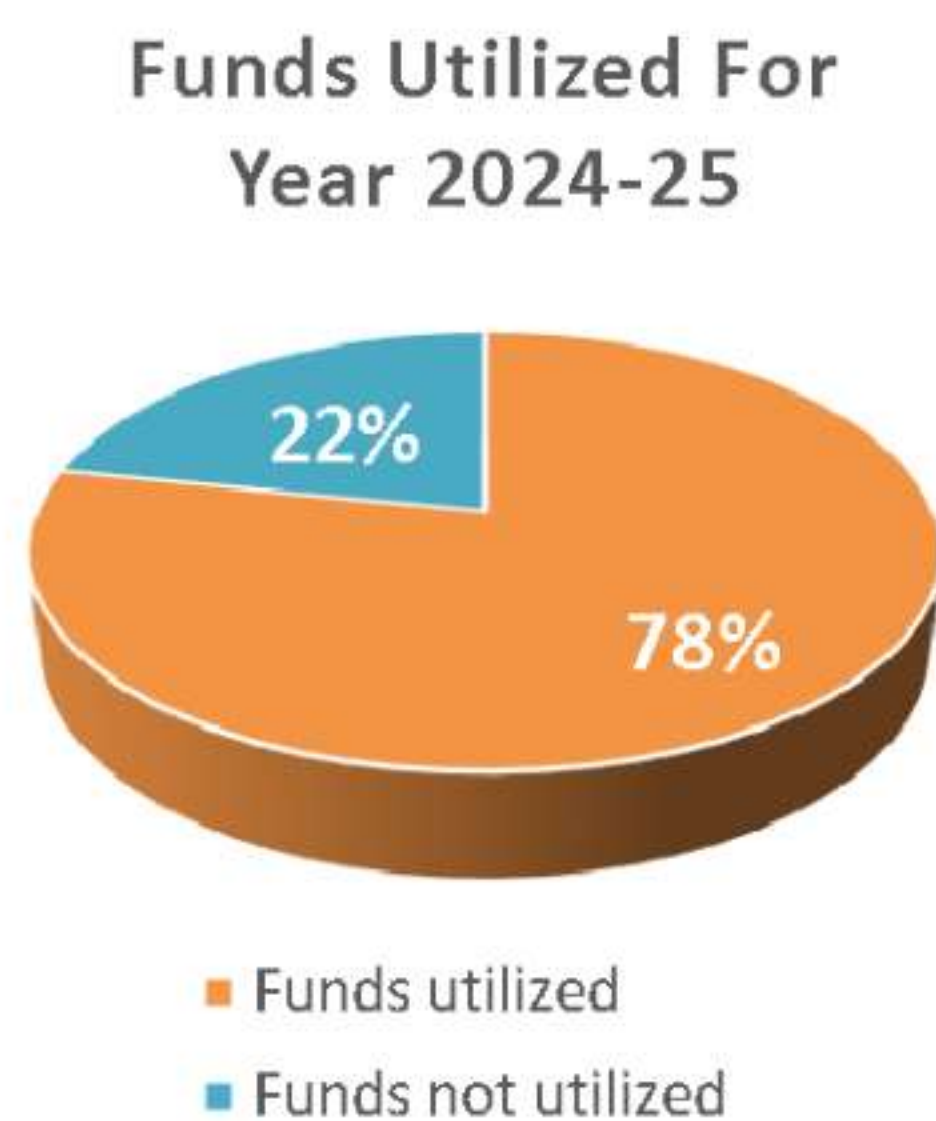
In pursuance to the Article 320 of the Constitution of India the Commission is consulted in the matters of Direct Recruitments, Promotions, Framing of Recruitment Rules and Amendments thereto, satisfactory completion of probation period, confirmations, continuation of ad-hoc promotions/appointments beyond one-year, Disciplinary Proceedings, in respect of Group ‘A’ and ‘B’ posts. Certain categories of the posts have been exempted from the purview of the Commission by virtue of the Goa Public Service Commission (Exemption from Consultation) Regulations, 1988.

The Commission presents to the Hon’ble Governor of Goa its Annual Report for the period from 1st April 2024 to 31st March 2025 in accordance with the requirement set out under Article 323 (2) of the Constitution of India.

7.WARRANT OF PRECEDENCE

There has been no change in the Warrant of Precedence. The Chairman of the Commission is shown in Article 23 along with the Chief Secretary and Director General of Police and the Member of the Commission is shown in Article 25.

8.FINANCIAL MATTERS



The Commission is provided with funds under Budget Head **2051**-Public Service Commission, **102**-State Public Service Commission, **01**-State Public Service Commission (Charged), **2071**- Pension and Other Retirement Benefits,**01**- Civil, **117**-Government Contribution for Defined Contribution Scheme, **01**-Defined Contribution Pension Scheme, **01**- Salaries and **4059**-Capital Outlay on Public Works, **01**-Office Building, **051**-Construction, **01**-Construction to GPSC - Building & Infrastructure. During the financial year i.e. **2024-25**, an amount of **₹943.20 Lakhs**

(Rupees Nine crores forty-three lakhs twenty thousand only) has been provided in the budget estimates. Though the Commission is not a revenue earning department, the Commission collected **₹ 50.43 Lakhs** (Rupees Fifty lakhs forty-three thousand only) by way of application fees, examination fees and R.T.I. fees, etc. during the period under report. The total expenditure incurred for the year under report is **₹ 737.04 lakhs** (Rupees Seven crores thirty-seven lakhs four thousand only).

11. ADVERTISING THE POST UNDER DIRECT RECRUITMENT

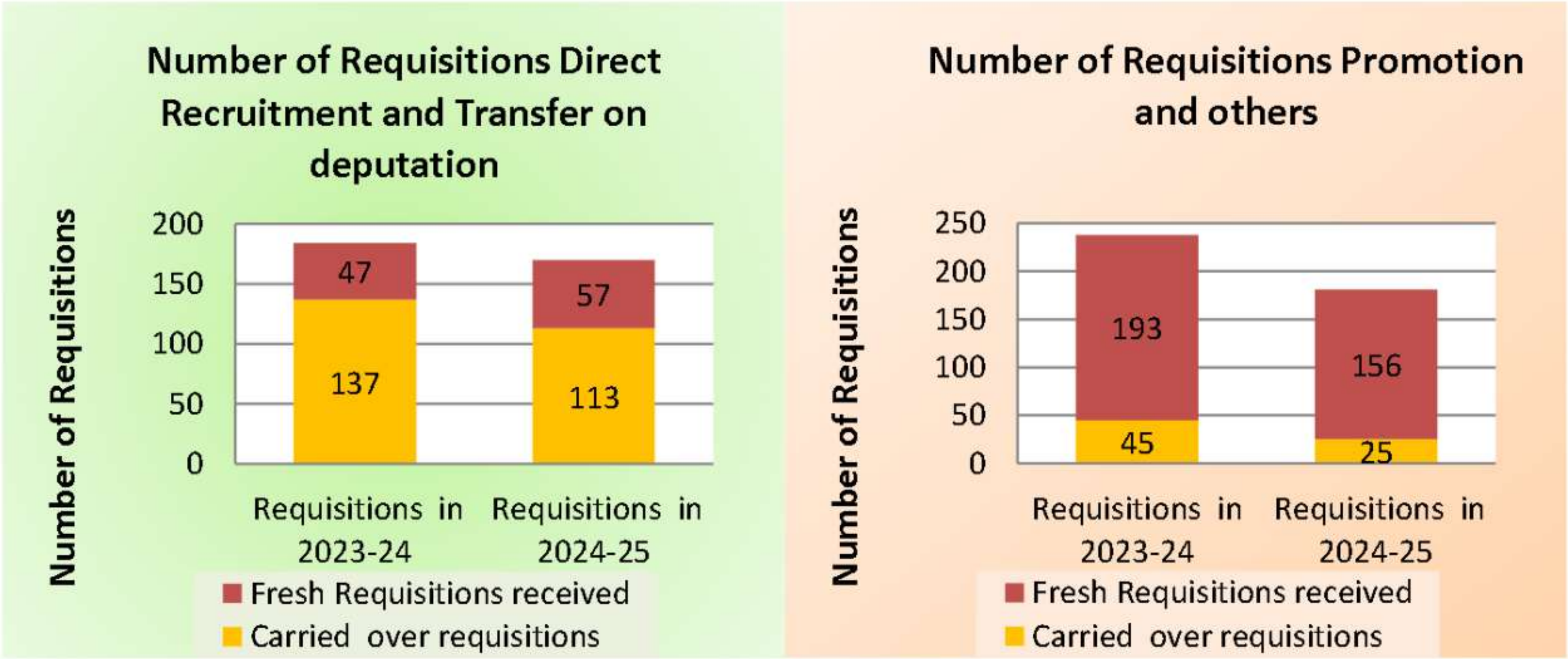
The Commission continued the policy of advertising the vacancies in 6 widely circulated newspapers in the State of Goa i.e. two English , one Konkani and three Marathi as under regularly:

- 1) Navhind Times and Herald (regularly)
- 2) Bhangarbhuay (regularly)
- 3) Tarun Bharat , Gomantak and Lokmat (regularly)

In order to facilitate the response from prospective candidates in rural areas, copies of the advertisements are sent to the Office of the Collectorate, Mamlatdar, B.D.O., Police Stations for displaying on their Notice Board. The advertisements are also uploaded on the Commission’s website for wide publicity and are sent to Goa Doordarshan and All India Radio. Similarly, advertisements notifying the vacancies are also published in the “Goa Vacancy and Tender Bulletin” issued by the Government Printing Press. Applications for all advertised positions are received online through the Commission’s website.

12. REQUISITIONS RECEIVED BY THE COMMISSION

During the period under report, the Commission received 53 requisitions for filling up the post by direct recruitment, 4 requisitions for filling up the post by transfer on deputation, **156 requisitions** for filling up the post by promotion and other requisitions such as framing of Recruitment Rules, Amendment of Recruitment Rules, satisfactory completion of probation period, confirmation, disciplinary cases, etc. The details of which are shown in **Statement I**. 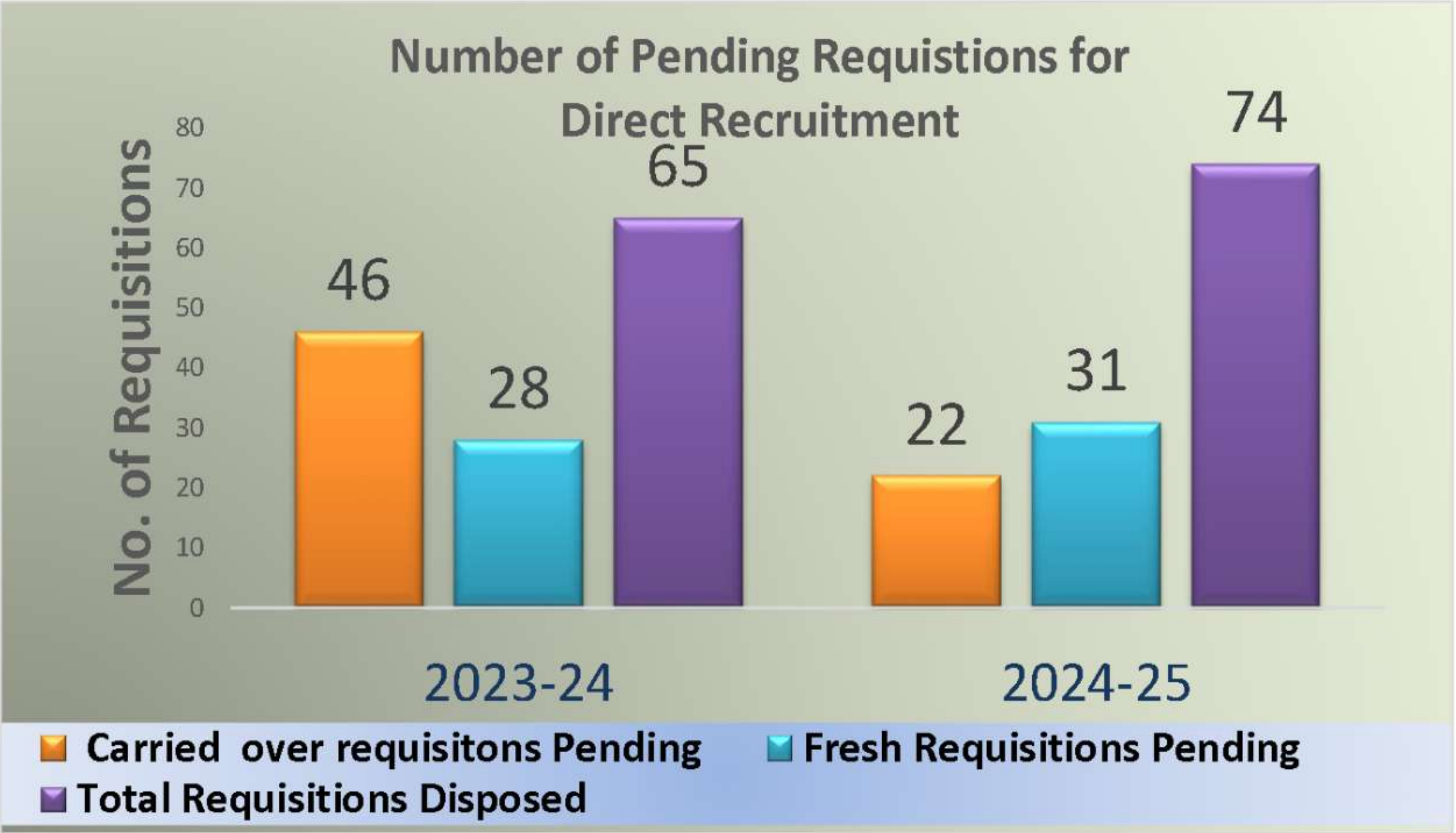


13. DIRECT RECRUITMENTS

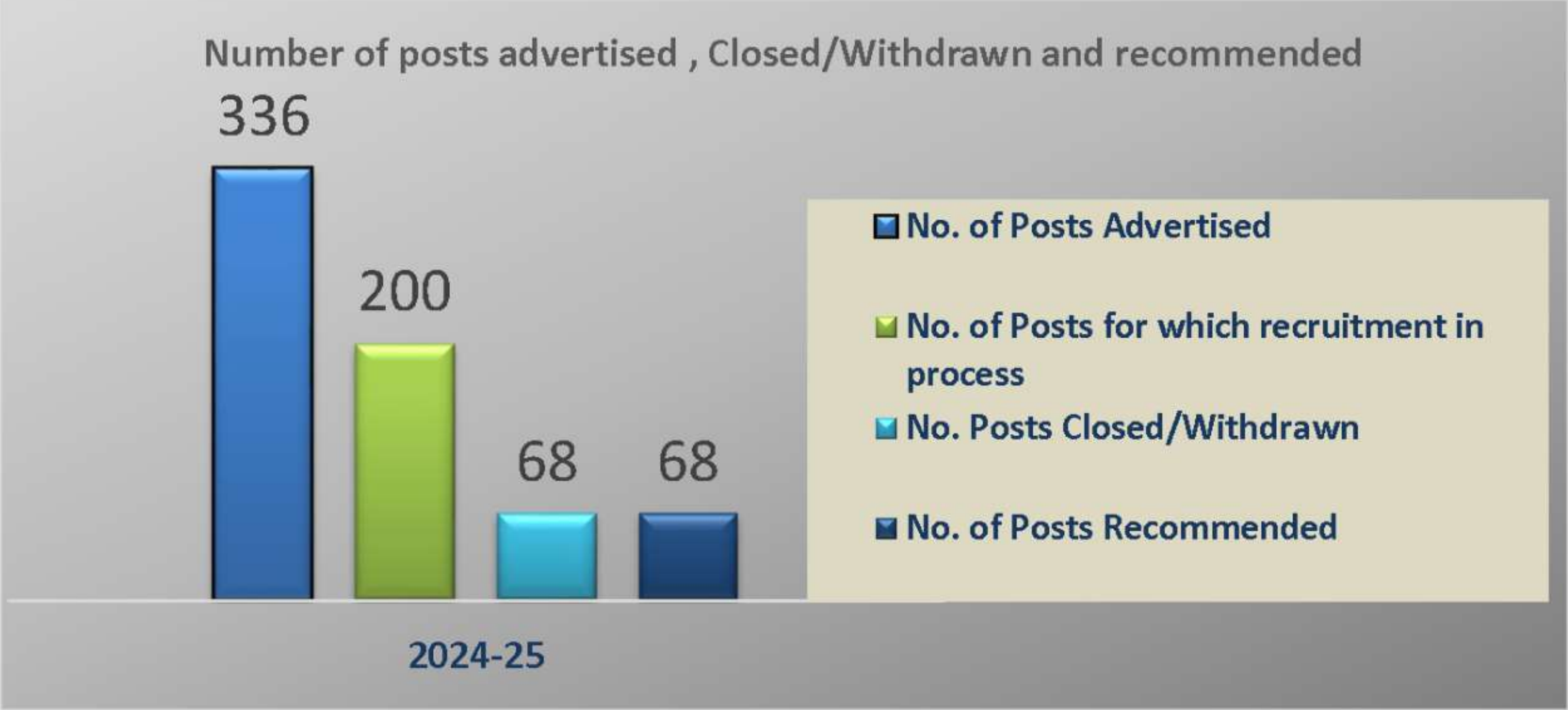
13.1 Requisitions

- a) 74 proposals were pending with the Commission as on 01.04.2024.52 Requisitions out of 74 are disposed off .The details are shown department wise in **Statement II**.
- b) During the period under Report, the Commission received 53 new requisitions from various Government departments for various posts. 22 requisitions out of 53 are disposed off. The details are shown department wise in **Statement III** during the period under report.
- c) At the end of the Financial Year, 53 proposals are pending as given in **Statement II and III**.
- d) 39 proposals were pending with the Commission as on 01.04.2024 for filling up the posts by Transfer on deputation/Short term contract out of which 32 are disposed off. 4 new proposals were received by the Commission for filling up the posts by Transfer on deputation/Short term contract. 1 requisition out of 4 is disposed off. At the end of the Financial Year, 10 proposals are pending as given in **Statement V** during the period under report.

14. NON-ACCEPTANCE OF THE COMMISSION’S RECOMMENDATION

Article 323 enjoins upon the Commission to forward a Report of its activities to the Governor, who shall cause a copy thereof, together with a memorandum explaining, as respect the cases, if any, where the advice of the Commission was not accepted, the reasons for such non-acceptance to be laid before the Legislature of the State.

None of the recommendations were rejected by the Government during the year under report.

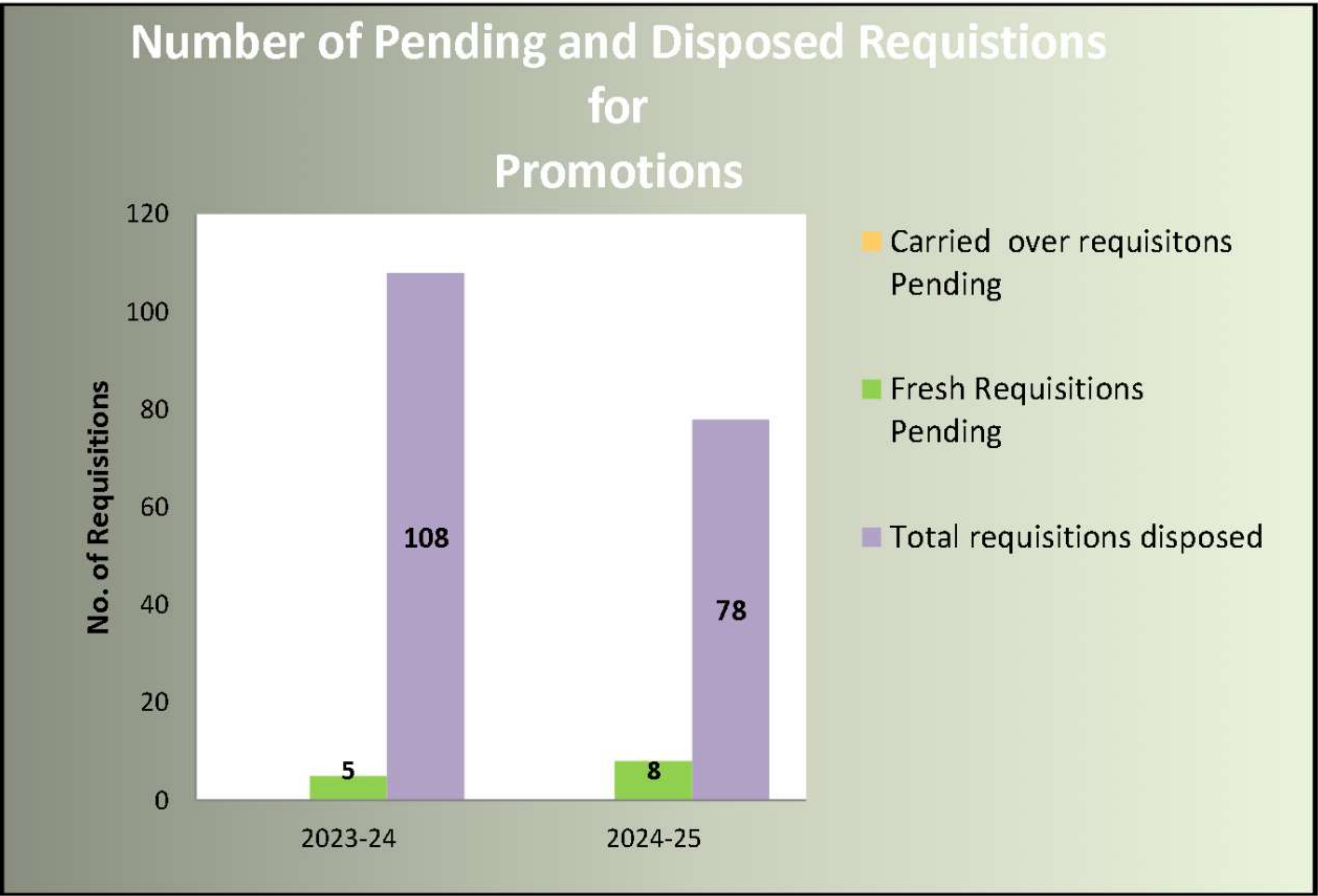

16. PROMOTIONS

At the beginning of the year, 05 proposals covering 24 vacancies were pending. During the year under report 81 proposals were received for 448 existing vacancies to be filled in the various Departments. The Commission disposed of 78 proposals which include 05 pending proposals of the previous year. 58 vacancies were returned/ withdrawn.

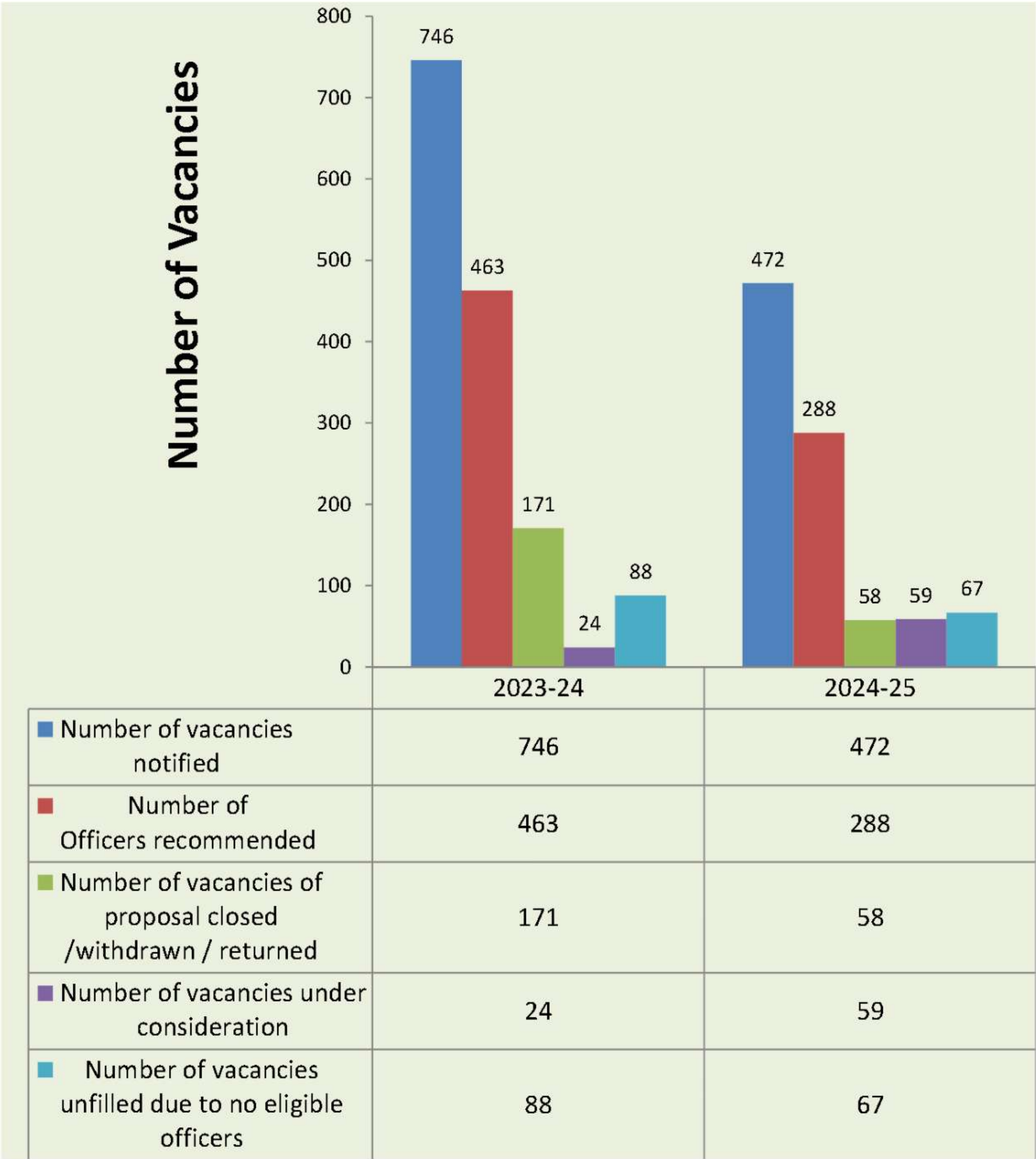
The Commission recommended 288 officers for promotion which include 20 Officers of the previous year. There were no eligible Officers for 67 vacancies, which include 04 vacancies of the previous year, hence the vacancies remained unfilled. The Commission convened in all 62 D.P.C. meetings. The details of the proposals received, disposed off as well as the decision of the Government on the recommendation of the D.P.C. are shown in **Statement – IV**. Around 08 proposals covering 59 vacancies are pending at the end of the year under report which is under scrutiny stage.

A pictorial representation of pending requisitions for promotions as per **Statement-IV** is as follows:



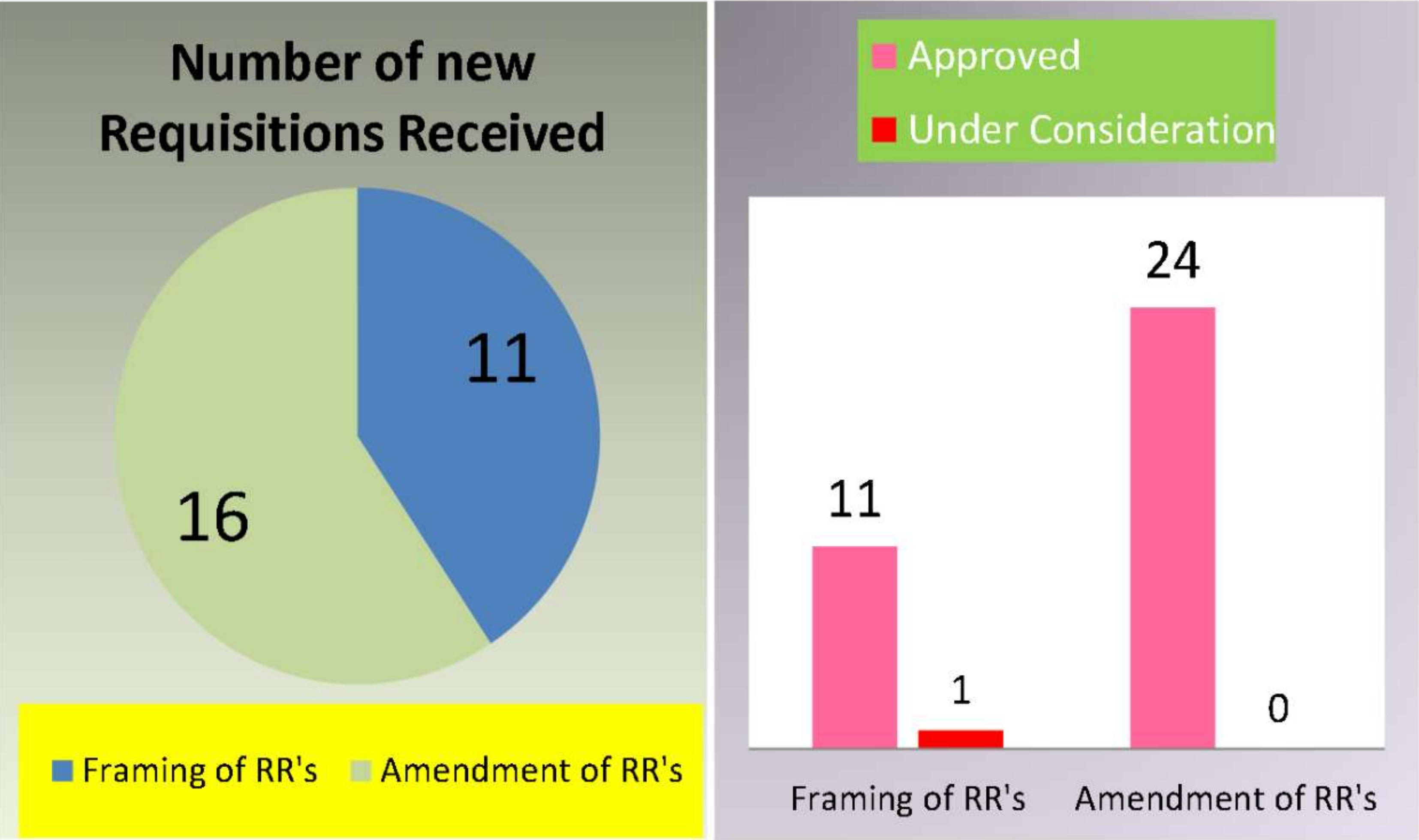
16.1 Statistical Abstract of Number of vacancies notified, to be filled by promotion and Number of officers Recommended.-

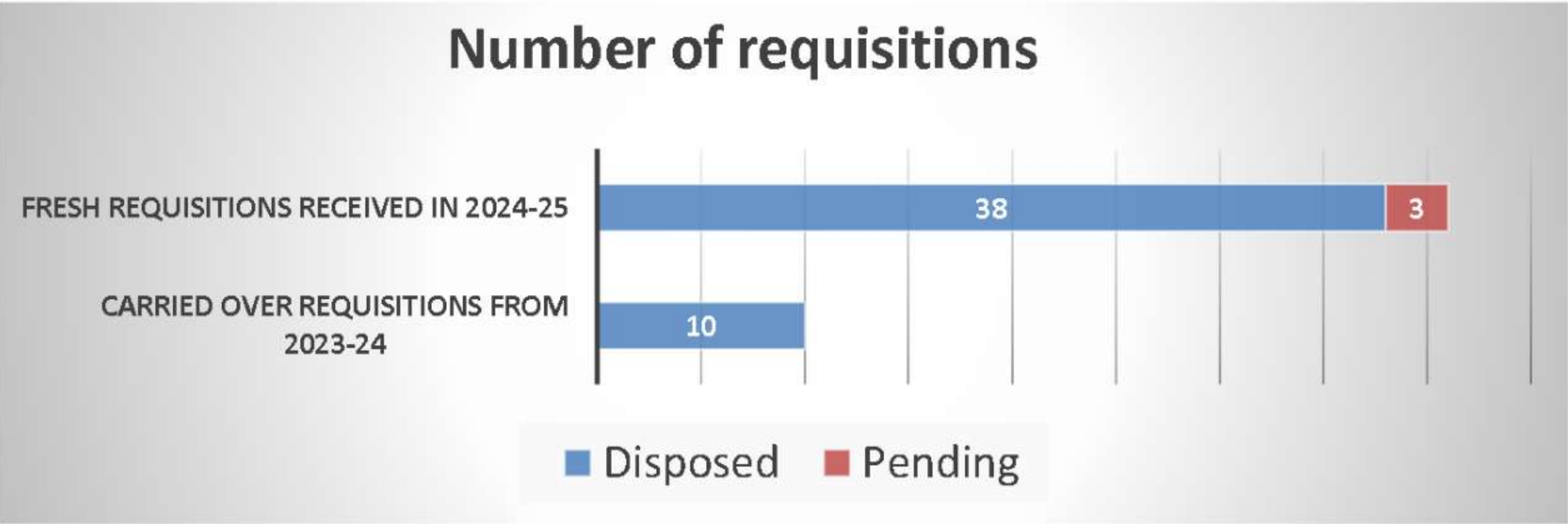
17. RECRUITMENT RULES AND AMENDMENT THERETO

At the beginning of the year, 01 proposal was pending for framing of new Recruitment Rules. The Commission received 11 proposals for framing of new Recruitment Rules for various posts in different departments. At the beginning of the year, 08 proposals were pending for amendment of Recruitment Rules. The Commission received 16 proposals for amendment of Recruitment Rules for various posts in different departments. The details are as per **Statement- VI**



18. CONFIRMATION/PROBATION PERIOD

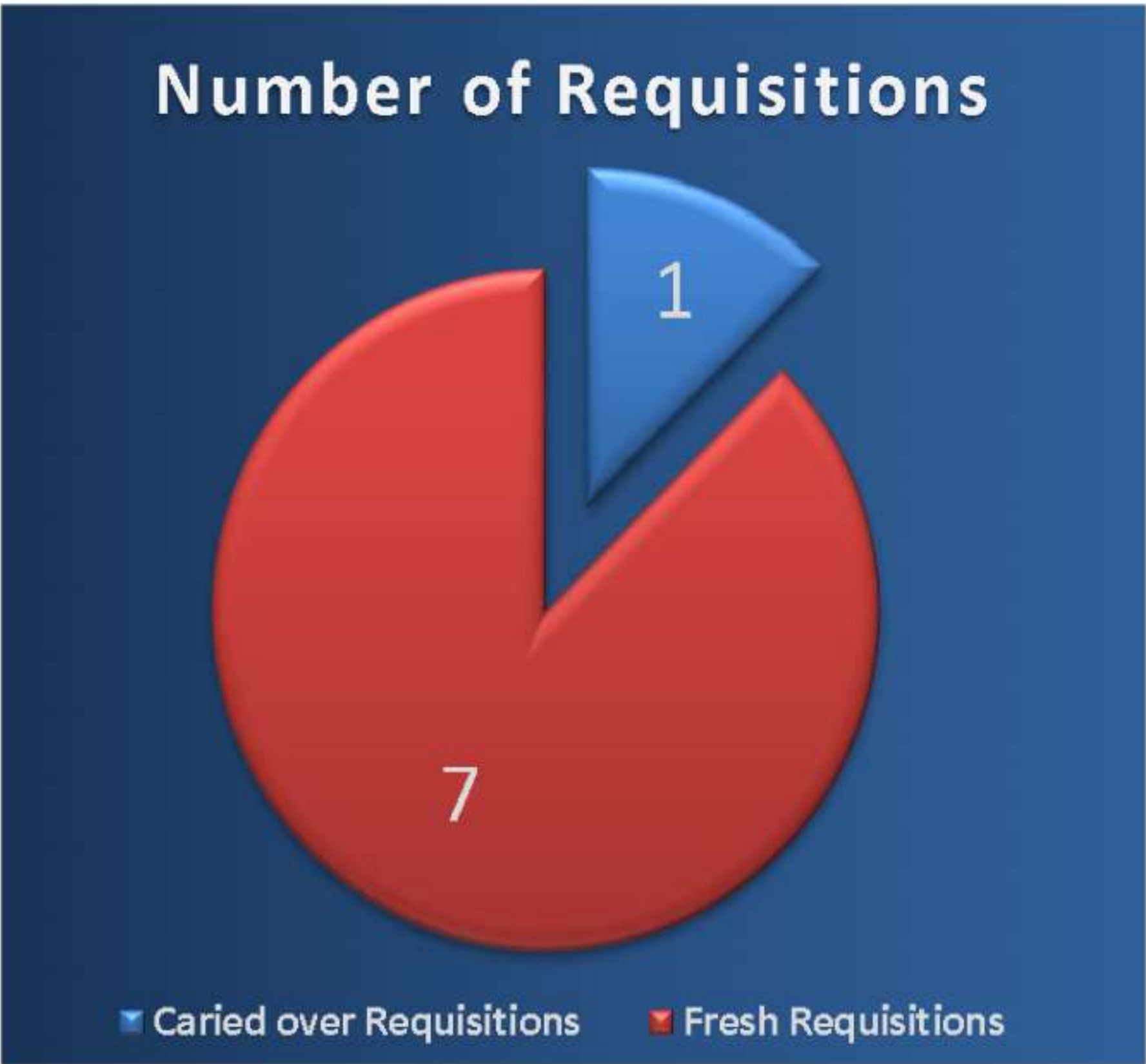
At the beginning of the year, 10 proposals were pending. The Commission received 41 proposals for confirmation and completion of probation period during the period under report. The Commission disposed off 48 proposals including 10 pending proposals of the previous year and recommended 176 officers. At the beginning of the year, **01** proposal was pending. The Commission received **07** proposals of Disciplinary cases during the period under report.

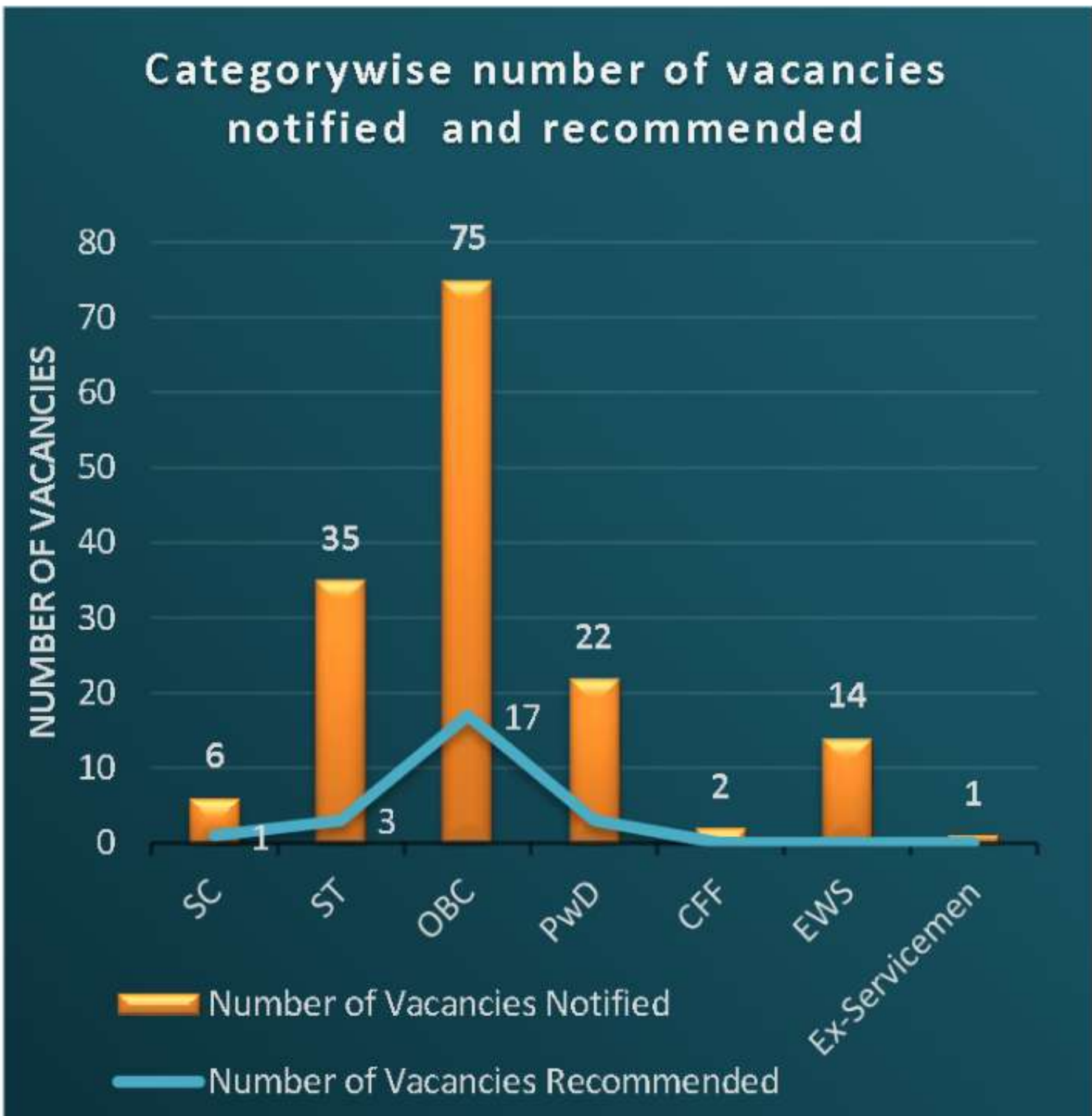

The Commission continues to recruit persons belonging to various reserved categories against the reserved vacancies but inspite of this, there is no response from eligible candidates belonging to SC, ST, OBC, PwD, CFF and EWS candidates. The details of the vacancies notified in favour of Scheduled Caste, Scheduled Tribe, Other Backward Class, Person with Disability, Children of Freedom Fighters , EWS and Ex-Servicemen are shown in Statement X .
